



## Terms and Conditions Tailored events

### Scope of application

All events organised by the Beetschen winery at the estate according to a custom offer, received separately.

### Number of participants

People cancelling less than three days before the event will be taken into account in billing for food and any other specific order for which the fees are already committed. A minimum of participants is often necessary for each service. So if that is the case, the amount corresponding to this minimum will be charged in case of lower number of participants. Offers for larger groups will be subject to specific conditions.

## 3. Choice of services

### The Oenothèque

The choice of tapas and wines are made à la carte unless there is a special order for a cocktail or other meals. Any conditions specific to your event are reserved.

### The winegrower's house

Depending on your event, the Beetschen winery will submit a customised suggestion for the selection of wines. That said, the final choice of wines and other drinks is made à la carte at your convenience. Note however that a minimum amount was set to cover service personnel costs specifically incurred and included in the delivery. The minimum amount charged will be CHF 30.- At a guest table with the presence of the chef, CHF 25.- at a convivial guest table (a winemaker fondue for example) or a cocktail, CHF 15.- for a simple appetiser and CHF 10.- at a luncheon during a seminar.

The menu is identical for all the guests. In case of a specific allergy or diet, please let us know in advance. If the menu has to be changed considerably, it may be that we will be obliged to charge you extra for this change.

Also note that any event organised on Sunday will be subject to a surcharge of 15%.

### Activities

For real activities organised in the estate, the services included in these activities but not included in the workshop are shown clearly in the offer and submitted separately.

## 4. Duration of the event

The time for service providers and staff is planned for a normal period in relation to the agreed services and is included in the official opening hours. However, we reserve the right to charge overtime at CHF 45.00 per hour per person engaged in case you want to get more out of the premises placed at your disposal. That said, we can not exceed the timetables set by the police regulations of the municipality. Please also respect the neighbourhood regardless of the hour.

## **5. Guarantee of reservation and payment terms**

A credit card number will be required to secure the reservation. For events organised directly at the Oenothèque, you can pay directly on site. Otherwise, we will send you an invoice after the event and will contact you by phone in order to cash through a credit card (Visa or Mastercard). On request, you can also make a bank transfer within 10 days following the event.

## **6. Cancellation (in case of complete cancellation of the event):**

Cancellation on the day following receipt of the signed contract will be charged 20% of the total amount of the offer.

Cancellation less than 10 days before the event date will be charged 50% of the total amount of the offer.

Cancellation less than 3 days before the event date will be charged 100% of the total amount of the offer.

## **7. Governing Law / Jurisdiction**

All disputes shall be subject exclusively to Swiss law. The jurisdiction is Nyon.

## **8. Amendments and additions**

The Beetschen winery reserves the right to modify these terms and conditions at any time.
